Zucchini Garden Chowder

undrained

INGREDIENTS

- •2 medium zucchini, chopped
- •1 medium onion, chopped
- •2 tablespoons minced fresh parsley
- •1 teaspoon dried basil
- •1/3 cup butter, cubed
- •1/3 cup all-purpose flour
- •1 teaspoon salt •1/4 teaspoon pepper
- •3 cups water
- •1/4 cup grated Parmesan cheese

•1 teaspoon lemon juice

•2 cups (8 ounces) shredded cheddar cheese

•1 can (12 ounces) evaporated milk

•1 package (10 ounces) frozen corn

•3 teaspoons chicken bouillon granules

•1 can (14-1/2 ounces) diced tomatoes,

•Pinch sugar, optional

•In a Dutch oven, sauté the zucchini, onion, parsley and basil in butter until vegetables are tender. Stir in the flour, salt and pepper. Gradually stir in water. Add the bouillon and lemon juice. Bring to a boil; cook and stir for 2 minutes or until thickened.

•Add the tomatoes, milk and corn; bring to a boil. Reduce heat; cover and simmer for 5 minutes or until corn is tender.

•Just before serving, add cheeses; stir until melted. Stir in sugar. Garnish with parsley if desired. Yield: 8-10 servings (about 2-1/2 quarts).

INVOLVE CHILDREN IN THEIR OWN HEALTH CARE, SURVEY SAYS

Sick children are often sheltered from discussions about their health care. But a study published in the Journal of Clinical Nursing suggests that health professionals and parents would do better to consult children more and include them in decisions.

Researchers in Ireland spoke with 55 young people, ranging in age from 7 to 18, with acute or chronic illnesses. Most had been hospitalized previously (71 percent), stayed less than seven days (85 percent) and lived with two parents (80 percent). Some of the study's findings were:

· Children said they want to take part in discussions about their health and treatment, and to have their views and concerns taken seriously.

· Knowing the health professionals helps children feel able to ask questions freely and express their concerns.

· Many children look to their parents to act as advocates and to explain what's happening, and they rely on their parents because they have problems communicating with health professionals.

• The way health professionals communicate and behave can be an obstacle to children's getting involved. Children said health professionals tend to "do things" to them with very brief explanations or none at all. Health professionals exclude them, they said, directing information at their parents using language they don't understand.

• Children want to make "small" decisions, but almost half want to leave "serious" decisions about issues like surgery to their parents and health professionals.

KEITH, OUR MECHANICAL ENGINEER

Our agency likes to share human interest stories that help us learn more about each other and our families. I thought that a story about an experience our son, Keith, had in his profession might be of interest.

Keith is the younger of our two children, is thirty-three years old, and is a mechanical engineer by education and profession. He loves to think up how to make or improve stuff. When he was about eight years old, he wanted to make a hot air balloon, so he built one out of napkins, string and cardboard in his bedroom; fun idea, but wrong place! He needed heat to get it to rise, so it made sense to put a little fire in the basket of the balloon. I won't share all the details, but suffice it to say we were greatly relieved that the damage to his bedroom was some smoke and melted carpet.

He's got the perfect way of thinking for an engineer (at least as an adult). He works on the east coast, in Connecticut, for a small "boutique" engineering firm. Most of his projects are for research and development (R&D), and fully funded by clients, some of which either have or are vying for contracts with the federal government, and especially the US military. One project/idea that his firm was asked to develop about 18 months ago was intended to save lives: their client viewed the statistics on the US Army Humvee and the incidence of bodily injury to soldier occupants when IEDs or

other assaults on the vehicles would cause their gas tanks, on the undersides of the Humvees, to explode. Keith was tasked to design a blast shield that might be able to reduce the number of explosions of the gas tanks and either direct or collateral bodily injury. He ended up designing an effective shield, which proved successful after several field explosive tests and a few design refinements. The company has filed a patent application, in which Keith is co-named as the inventor, since he developed it under their contract. Since then, Keith and their corporate client have found a variety of other applications for the idea in which the damage of either explosions or other rapidly released and focused energies can be moderated and hopefully save lives and property. It's always gratifying as a parent to see our kids succeed. This is one of those times.

What Happens to Your "Digital Assets" After You Die?

"We finish this month, delving into the vast subject of online assets and how to protect them when you die.'

Default Rules In Absence of Will: What Happens After You Die

Previously we talked about how to deal with your digital assets. If you take time to create a will for digital assets, it would save much effort on the part of your kin. What happens if you fail to create a will for your digital assets? The following is a sampling of the leading companies and their policies. Most companies have forms to be completed by the kin for notifying them of a death. You may need the profile URL and email ID of the dead user plus other documentation.

<u>LinkedIn:</u> LinkedIn simply closes your account – when any of your kin or friends inform LinkedIn about your demise. No one gets to access the account and LinkedIn won't provide any data to anyone.

Twitter: When you inform them about the demise of a user, they will digitize all the public tweets of the user and hand it over to the beneficiary before closing the account. They do not transfer the account to anyone else.

Facebook: They neither close the account nor transfer the account to your kin. It "memorializes" the account so that it can be viewed anytime by the current Facebook friends of the deceased. Friends can continue to log in it to post messages, etc.

Google: Their policy is not very clear. They may or may not provide the kin with access to the deceased's email.

Microsoft Hotmail: Microsoft will delete a Hotmail account if it has been unaccessed for over 270 days. If you wish to access the Hotmail account of your deceased relative, you have to contact Hotmail. Hotmail will give you access for 6 months.

Yahoo Mail: Disables your account if there is no activity for four months.

PayPal: Will keep the account as long as you have a balance in it. Thus, neither the company nor the kin of deceased can make use of these digital assets in the absence of a proper will. The above companies have formed policies to take care of users who cease to exist, but there are many other companies on the Internet that are yet to make such policies. The list of such companies includes major photo sharing sites, cloud storage sites, music sharing sites and more. There are some companies who have certain sets of rules when it comes to accessing data of dead users. Note that these rules may be overridden by court's ruling in favor of the deceased's kin in certain cases. Once again, the best method of passing on the digital assets you have collected during your lifetime, is to create a separate will and transfer your accounts to your kin.
