CAUTION! Are you a drone owner?

Aviation exclusion shields insurer from covering drone accident

A drone is still an aircraft, even if it does not carry passengers or cargo, says a federal court in ruling a Tokio Marine Holdings Inc. unit is not obligated to defend or indemnify a photography firm whose drone injured a wedding guest's eye under an aviation policy exclusion.

A guest who attended a 2016 wedding that was photographed by Corona, California-based Hollycal Production Inc. using a drone allegedly lost use of her eye when the drone made contact with it, according to Friday's ruling by the U.S. District Court in Santa Ana, California, in Philadelphia Indemnity Insurance Co. v. Hollycal Production Inc. et. al

The injured woman filed suit in state court against Hollycal, its owner and an employee. Tokio Marine unit Philadelphia Indemnity, which is based in Bala Cynwyd, Pennsylvania, agreed to defend the company under a reservation of rights.

The insurer then filed suit in the U.S. District Court, seeking summary judgment as to whether Hollycal was entitled to coverage under its insurance policy.

The court ruled it was not. The firm's policy includes an exclusion for bodily injury or property damage involving any aircraft it used, said the ruling.

The firm had argued the drone did not fall within the exclusion because a "drone equipped with a camera is not capable of transporting persons or cargo," but it rather is "unmanned and operated remotely."

The drone is still an aircraft, said the ruling, however. "The ordinary definition of an aircraft does not require the carrying of passengers or cargo. Additionally, that a drone is unmanned and operated remotely does not make it less of an aircraft," said the ruling, in holding the insurer does not have a duty to defend or indemnify the defendants.

Print Books Remain in the Lead

Books are alive and well in the digital age, but we're consuming them differently from the way we have in centuries past. The Pew Research Center reports that 74 percent of Americans say they've read a book in the past year, a figure that's remained fairly constant since 2012.

We're not all "reading" the same way, though. Print books may be the most popular format, with 67 percent of Americans reporting they've read one in the past 12 months, but the share of Americans consuming audiobooks has increased from 14 percent to 18 percent since 2016.

E-books are also a factor in our reading choices, though they're not taking the place of paper for now. Thirty-nine percent of readers say they read only physical print books, although 29 percent say they read both print and digital books. Just 7 percent report reading books exclusively in digital format and say they haven't read any dead-tree books in the past year.

February - the shortest month of the year

Have you ever wondered why there are only 28 days in February? The answer dates back to ancient Rome. It is believed that Numa Pompilius, who reigned around 700 B. C., wanted to more accurately synch the 10-month Roman calendar with the annual lunar cycles. He added the months of January and February to fall between the months that ran from March through December.

The addition of these two months became a bit of a problem, because Romans were very superstitious. Even numbers were considered unlucky, and the lunar year was 354 days. In order to keep the days of the year at an odd number, the king made the new calendar 355 days. January was given 29 days and February 28 to achieve this number. Because February was now the unlucky month of the year, it was observed as a time when the Romans performed rites of purification and honored their dead.

Hundreds of years later Julius Caesar would make more changes to the Roman calendar. Around 45 B.C., Caesar added 10 additional days to the calendar so that it more closely resembled the solar-based Egyptian calendar. At that time, an extra day that would occur every four years was added to the month of February, giving us the leap year.

Stay Focused with the '24-hour rule'

Renowned pro football coach Don Shula's successful career was based, in part, on a policy of looking forward to the next challenge instead of dwelling on his previous victories or failures. Shula's "24-hour rule" exemplified that.

The coach allowed himself, his fellow coaches, and his players 24 hours at the maximum to celebrate a victory—or agonize over a defeat. Shula encouraged them to feel the emotions of success or failure as deeply as they could. After 24 hours, though, the team was expected to stop talking and thinking about the experience and focus their concentration and creativity on preparing for the next game.

One of the fastest growing methods of hackers today is to pose as a trusted mortgage professional or escrow agent through email. The email will contain the proper logos and images of the individual to convince you to perform a wire transfer for your mortgage transaction. **DO NOT WIRE FUNDS to anyone without contacting them to confirm the transaction over the phone.** Do not use the phone number on the email. Only call people with knowledge of the transaction using their business cared or a search on the internet. This fraudulent activity is not limited to real estate-type transactions only - ANY wire transaction could be phony.
